THEME:

**AFRICAN CHURCHES ON ISRAEL AND PALESTINE.**

OCTOBER 6<sup>th</sup> – 10<sup>th</sup>, 2025

NAIROBI – KENYA

#### 1.0 BACKGROUND / CONTEXT

The All Africa Conference of Churches (AACC -CETA), through its Theology and Interfaith Relations unit is committed to providing a platform for constructive conversations about addressing contextual misleading theologies in Africa. AACC has been holding annual theological symposia. The 1st symposium was held in from 23<sup>rd</sup> – 27<sup>th</sup> October 2019 where critical areas of misleading theologies were identified for further engagements in future symposia. A series of symposia took place annually addressing thematic areas of Complexities of Theologies of Wealth and Prosperity (on 23<sup>rd</sup>-27<sup>th</sup> November, 2020), Controversies about Theologies of Health and Healing (on 22<sup>nd</sup> -24<sup>th</sup> November, 2021), Addressing Contextual Theologies of Power and Authority in African Churches (on 19<sup>th</sup> – 23<sup>rd</sup> September 2022) and The Role of Governments' Regulation on Churches and Religious Institutions (RIs held on October 28<sup>th</sup> -1<sup>st</sup> November 2024. This year's annual theological symposium will be held from 6<sup>th</sup> -10<sup>th</sup> October 2025 at Desmond Tutu Conference Center (DTCC) with the theme: **AFRICAN CHURCHES ON ISRAEL AND PALESTINE.**

#### 2.0 RATIONALE

The rapid growth of African Christianity both the main-stream churches as well as Pentecostal-evangelical movements is resulting to a closer relationship with Israel and Palestine. The relationship is growing as various churches in Africa as well as individual Christians strongly associate themselves with the fulfillments of Abrahamic covenant, biblical prophecies, eschatological and prosperity gospel<sup>1</sup>, creating a geopolitical situation of pro-Israel and/or Pro- Palestine supporters within the continent. Consequently, the multi-dimensional aspect of the relationship promotes AACC to host 6<sup>th</sup> annual theological symposium, inviting

theologians, church leaders, scholars and pilgrims into a conversation that will explore African Churches relationship and understanding of Israel and Palestine.

**Key questions this symposium will seek to answer are;**

- a) What are the factors contributing to the growing relationship between African churches, Israel and Palestine?
- b) What are the biblical hermeneutical approaches authenticating African Christianity connection to Israel and Palestine?
- c) What are the theological perspectives of African Christian pilgrimage to the holy sites?
- d) What are the ecclesial authenticities and identities emanating from the relationship between African Christians, Israel and Palestine?
- e) What are the geopolitical, theological and spiritual implications of today's African relations to countries of Israel and Palestine to the African Christianity.
- f) What are the Middle East Christians' expectations from the churches in Africa.

**3.0 OBJECTIVES**

- To provide a platform for constructive conversations on African Churches Theological Perspectives on Israel and Palestine.
- To bring together up to 100 participants including theologians, church leaders, scholars' and frequent pilgrims to explore different aspects of relations between African Churches, Israel and Palestine.
- To Publish the symposium papers/articles in to a book series addressing contextual theologies in Africa today.

**4.0 Thematic Focus Topics**

- a) Historical and Biblical relationship between African churches, Israel and Palestine.
- b) Biblical hermeneutic approaches Informing different perspectives.
- c) Theological perspectives on Christian pilgrimage to the holy sites.
- d) Ecclesial authenticities and identities on relationship between African Christians, Israel and Palestine.
- e) Geopolitical Interests, Theological and Spiritual implications on relations to countries of Israel and Palestine.
- f) Middle East Christians' expectations from the African churches.

## **5.0 TARGET**

This symposium will target 100 participants composed of church leaders, leading theologians and frequent pilgrims, theologians from middle east and Africans in diaspora who may be interested. A few partners will be invited as well as representatives from Israel and Palestine.

## **6.0 METHODOLOGY**

The methodology to be used will include paper presentation, panel discussions, plenary discussions, group discussions, case studies and sharing of perspectives. Sharing will be in person or/and short videos/clips.

## **7.0 IMMEDIATE AND SHORT-TERM EXPECTED OUTCOMES**

- Enhance understanding of the African churches' relationship with Israel and Palestine.
- Examine various biblical hermeneutical approaches to Zionism and pilgrimage.
- Analyzed possible gaps causing the misinterpretation of ecclesial authenticities and identities and the impact on African churches.
- Proposed theological approaches addressing geopolitical interests, theological and spiritual implications of today's African churches.
- Propose ways to address middle east churches expectations.
- Published the symposium papers/articles in to a book series addressing contextual theologies in Africa in which the link to the publications will be circulated widely within the AACC networks.

## **8.0 SPEAKERS**

Speakers will be identified and selected from the list of applicants who will have submitted abstracts as per the symposium requirements (*requirements will be published together with the symposium advert at: [www.aacc-ceta.org](http://www.aacc-ceta.org)*). We intend to benefit from the expertise of church leaders, professional, theologians and lecturers in theological schools across Africa and beyond. Speakers will be selected from their areas of theological expertise and experiences. They will be notified on time preferably during the 1<sup>st</sup> week of the month of June.

## **9.0 DATES AND VENUE**

This symposium is planned to take place for **3 days in October 2025** with the arrivals on **6<sup>th</sup> October 2025** and departures **on 10<sup>th</sup> October 2025** in Nairobi, Kenya at the Desmond Tutu Hotel and Conference Centre.

## **10.0 COSTS**

Interested participants are encouraged to contribute towards the Symposium through travel costs and conference fees (accommodation and meals).

The deadline for submission of the Application form is **15<sup>th</sup> May 2025**.
